## President's Message

Wharf Bank Loan. The loan taken out by the LIC and generously guaranteed by Geoff Bailie and Lynn Larson has been repaid in full, about a year ahead of schedule. Doing so saved us about \$5500 (\$4000 for flood insurance required by the bank, and \$1500 in interest). This leaves us with less cash reserves than we would like, and rebuilding those reserves is our next job. If all goes well we will be on schedule to begin repaying our membership wharf loans in 2015; until then we will continue paying the interest on those loans as usual.

Clubhouse Refrigerator. It has begun to fail and unpredictably shut off. It can't be properly fixed and must therefore be replaced. Talk about timing: the current profit from our award-winning cookbook and art is almost exactly the cost of a new commercial fridge. The cookbook crew is gathering bids and will soon select a replacement.

Save your Spring-Cleaning Items. The LIC Garage Sale is scheduled for April 12th, and we will be looking for donated items to sell at the event. It's a win-win deal: you get rid of stuff taking up room at home and the LIC makes a few bucks. Jan and Denny Prichard are again organizing the event; you will be seeing publicity about it soon.

The Down Key Festival, our fund raiser the weekend of May 16-18 for the LIC and its scholarship fund is shaping up! Events will be held aboard a historic ferry boat tied up at the marina, and at the clubhouse. This will be a true community celebration of our Longbranch heritage and our peninsula youth. Elementary, middle and high school students will be participating all three days. A large number of our members are busily planning the details, under the leadership of Connie and Rich Hildahl. Our March membership meeting on the 19th will feature a status report and discussion of the event. Please save the May date and plan to be involved.

Volunteer Hours. Please find and read the article by Kurt Anderson elsewhere in this newsletter about the importance of reporting your volunteer hours, whether you "need" them or not. Every recorded hour has an indirect value to the LIC.

Dock master Lynn Carr: reported that the marina had a visit from the Shelton Yacht Club. The card reader on the gate lock is working again. The Tacoma Power Squadron is planning its annual LIC work party for fall instead of springtime this year.

Rental Agent Kim Chaney: absent - no report Secretary Judy Riggs: It was MSP to accept the Jan 2014 minutes as written.

Events Chair Tim Heitzeman: reports that the Pancake Breakfast was a big success bringing in many community members as well as our LIC members. Tim is looking for someone to help with publicity for the LIC.

Membership Chair Eloise Colbert no report. Thanks to the General Meeting hosts Dee and Dick Scharfe, and Anne Dearing Treasurer Francie Carr was absent. Clark Van Bogart reported in her place that the money from permanent moorage, memberships and rentals minus the expenses came in above the expected income budgeted for this month.

Grounds and building Chair: the flag pole is beyond repair and must be replaced. Right after the snow storm, the LIC field was vandalized and torn up by vehicles. The septic drain field was spared by the big rocks placed along it for protection.

Marina Chair Denny Pritchard reported that the meetings with the DNR concerning the upgrades to the marina for the upcoming 2017 lease are going well. The marina committee is looking for a volunteer mapmaker to take on the task of designing a flyer showing points of interest within walking distance for marina visitors.

Trustee at Large: Phil Johnson had nothing to report this month.

Vice President: Clark Van Bogart had nothing to report this month.

President: Gayle Brewer reported that the Bank Loan for the wharf was paid off in total this month. By doing this instead of continuing the scheduled payments, the LIC saved a 25% increase in insurance for required flood insurance. The LIC will continue to pay off member loans as planned. Also, the LIC needs a volunteer to attend the monthly meeting of the Key Peninsula Community Council which meets the same night as the LIC Board meeting (2nd Wed of the month) to represent the club.

Peg Bingham reports that the kitchen crew reported that the LIC kitchen refrigerator has stopped working off and on. She reports that the sale of the LIC cookbook and art have generated enough money to purchase a new one and the kitchen committee are currently researching options. Also, the LIC cookbook won a publication award from The Heritage League for the whole package including recipes, art and historic content. Thanks to Carolyn Wiley for the information to apply for the award, and Gayle Brewer for writing the letter of recommendation.

Connie Hildahl gave an update on the plans for the May 16, 17, and 18 fund raiser. A full weekend is planned with activities for all, and anyone wishing to help with the event is welcome to give her a call at 884-1400.



## They Made It To Bair At Minus Six C

Over the past two summers the LIC boating group, more commonly known as the BLFF (Boaters Looking For Food), has gone on six breakfast, brunch, or lunch outings. We try to bring along as many non-boat owners as we can rustle up, and we often combine our meal outings with some kind of event or tour. We almost always get between 20 and 24 participants for a summer outing, and the total number of individuals who have participated at least once is around 35.

This year a number of the regulars asked if we could try a mid-winter outing, and I agreed to put one together. But, I made it clear that once we made our group reservations with a restaurant, we really needed to show up regardless of the winter weather conditions we encountered. Little did we realize when we made our February 6 breakfast reservations for a dozen people with Bair Drug in Steilacoom that the highest temperature of the day would end up being 30 degrees. When the boats arrived at the dock in Steilacoom that morning, the temperature had only climbed to 22 degrees, and if you add in the wind chill factor from the five mile per hour northerly wind, the participants were facing a 15 degree temperature for the  $\frac{3}{4}$  mile uphill hike to the restaurant. Fortunately the plans included transportation by vehicle to and from the restaurant, so everyone piled into the cars and made the quick trip up the hill to the warmth of our destination. - Everyone that is, except Barb Van Bogart and Betty Lewis, who in a true show of "courage," hiked up the hill through the 15 degree wind, arriving even before the cars got there.

The food, fun, and friendship was great as always, and about 90 minutes after we arrived, everyone began suiting up and getting ready to head back down to the dock, where the temperature had already climbed clear up to 24 degrees (17 degrees with wind chill). As two of our male participants were conferring with me to make sure the "limo service" was still available for the return trip to the dock, Mary Mazur announced that she would be walking back down to the boats. That, for some unknown reason, quickly terminated the limo discussion, and soon all those who had come by boat were heading back to the dock on foot. It was a great outing and a fun adventure.

So if you see a few of your fellow LIC members walking around with baseball caps that say "I made it to Bair at -6 C" (that's minus 6 degrees Celsius), those are some of the 13 brave souls that ate breakfast at Bair Drug on the morning of February 6, 2014. – Come and join us on our next outing. It's always fun, and sometimes turns into an outright adventure.

## Why You Should Report Every Single One of Your Volunteer Hours

The recording of every one of the volunteer hours worked by our members is very important to a non-profit organization like the LIC. There are many different reasons for this, including the ability to provide local entities with an accurate count of our total annual volunteer hours, and to help provide part of the basis for our continued status as a 501 (C) 4 non-profit corporation. But possibly the most important reason of all is what each one of these hours might provide if we choose to apply for one of the many grants that have become increasingly necessary in this age of economic belt tightening.

There are three primary ways that these hours can be used to help us acquire grants from either government programs or private foundations. First of all, these hours are often the primary way a possible grantor evaluates the effectiveness of a volunteer organization. A comparison of the ratio of the total number of club members to the total number of volunteer hours gives them insight into whether the organization is primarily a social club, or whether it has a history of being a force for action within its community. Secondly, it helps a grantor get a feel for whether there is going to be a ready and willing volunteer workforce available to undertake the many volunteer activities often associated with a project that they might fund. Thirdly, and often most importantly, is the fact that most of the time the monetary value of these hours can be used as the matching funds portion of a matching-funds grant.

The vast majority of currently offered grants fall into this category. For example, a grantor might offer a non-profit organization \$10,000 toward a project, with the requirement that the non-profit matches that with their own \$10,000. But in many cases the non-profit doesn't use actual money, but instead it uses the monetary value of volunteer hours as its \$10,000 portion of the matching grant. The monetary value of these hours is different for each state in the union, and that value is calculated annually by the Bureau of Labor Statistics. Currently the hourly value for Washington is set at \$22.69. That means if 150 of our LIC members were to each log 10 hours of volunteer work this year, we would have put ourselves in a position to seek a matching-funds grant of over \$34,000. Of course the reverse side of this equation is that if each member of a 200-member club fails to report just one hour of volunteer work in a given year, the club is potentially losing out on over \$4,500 in possible grant money. That makes every volunteer hour that you work very valuable to the LIC. By the way, your driving time to and from the volunteer activity can be counted in your hour total if your only reason for going to the location of the volunteer work is the volunteer activity itself.

In the past two years, both the Key Peninsula Civic Center and the Key Peninsula Historical Society have received multiple matching-funds grants based, in part, on the monetary value of their recorded volunteer hours. In the future, every one of your volunteer hours may prove very important to the continued success of the LIC. Please take the time to make sure that ALL of them are recorded and submitted to the LIC. At the present time that means making sure that a LIC Volunteer Activities Sheet gets to the LIC Membership Chairperson, which at present is Eloise Colbert.
