# LIC Declaration of Waiver

Comes now the undersigned, a tenant leasing marine space from the Longbranch Improvement Club and hereby agrees and consents to the following:

1. NO BAILMENT NOR WAREHOUSING PROVIDED. The undersigned acknowledges that the Longbranch Improvement Club does not provide bailment or storage facilities at the Longbranch Marina, and the relationship between the undersigned and the Longbranch Improvement Club is that of tenant and landlord, respectively.

2. LIMITATION OF LONGBRANCH IMPROVEMENT CLUB LIABILITY. The undersigned accepts the premises in their present condition and agrees to keep them neat, clean, orderly, and as free as possible from all flammable substances. The undersigned further agrees that the Longbranch Improvement Club shall not be liable for any damage to property or for personal injury caused by any defect now on the dock or near and around the rented premises or any part of appurtenance thereof becoming out of repair, arising from fire, storm, tides, bursting or leakage of water, gas, sewer, steam, or waste pipes, or from electrical wires, or from any act or neglect of any member, tenant, or any other users of said premises, or any person whomsoever, or due to the happening of any accident from whatsoever cause in or about said premises, and that the Longbranch Improvement Club shall be free from all obligation for loss, or damages to personal property of the undersigned or of any other person, or for personal injury, due to fire, wind, storm, water, theft, or any other cause whatsoever; but that all personal property of the undersigned shall be at the risk of the undersigned only, and the undersigned shall be entirely responsible and liable for any damage to the boat or other property kept on the rented premises leased by the undersigned.

3. COMPLIANCE WITH LAWS AND REGULATIONS. The undersigned agrees to comply with all rules, regulations, and special instructions issued by the Longbranch Improvement Club.
